Thank you for your interest in Tsa-La-Gi Yacht Club of Jackson Bay Marina. The following information has been assembled to help answer some of your questions about the Club and how you become a member. Like a marina, we offer slips, moorings, launching ramps, a rigging dock, bathhouse, storage yard, service hoist, limited camping facilities, Ship's Store and a full-time caretaker. However, as a Yacht Club, we offer everything from ...laid back cruises and highly competitive sailing regattas to raft-ups, onshore picnics, dinners, etc.

The Tsa-La-Gi Yacht Club sponsors a variety of sailing activities, with the main emphasis on fellowship. It is basically a club for family participation, with the members themselves doing most of the work. The Club has been built-up through many years of effort by people who share an enthusiasm for sailing. People who enjoy the companionship of meaningful work ashore and keen competition on the water.

Most repairs and improvements to the facilities are done by the membership on a voluntary basis. We plan, organize and carry out our own work parties and social events. Strong membership participation has made Tsa-La-Gi Yacht Club one of the finest yacht clubs in Oklahoma.

Each year, in early November, the Annual Meeting is held to elect Directors and Officers for the coming year.
