This waiver assumption and indemnification is to be in force and effect as long as the member is in good standing.

A STOCK PURCHASE is required plus initiation fee (1/2 - \$200, required with application) to join Tsa La Gi Yacht Club and an annual MEMBERSHIP FEE is payable in advance of each calendar year. The annual FULL MEMBERS FEE includes dry storage of one boat in the boat storage yard (ask about exceptions) and use of all the facilities. The SOCIAL MEMBERS FEE does not include fees for boating facilities (harbor pier ramp, grounds, etc.) OTHER USE FEES are charged to reflect the needs and requirements of the member and are charged separately for: extra boat and/or trailer storage (per unit stored); dockage in slip or on a mooring; camping in Corp approved area. Additional fees are assessed for use of electric on the docks, when available, and in the camping area. Labor charges when requested by a member or provided to protect a member's property will be assessed on an 'as used basis'.

The Treasurer provides itemized statements after acceptance of the new members by the Board of Directors of the Club and annually to all members.
